







This Office has crafted a Regional Child Protection Behavioral Standards for student engagement during the conduct of Palarong Pambansa (Palaro), as one of the vital activities covered by such standards.

To fully operationalize the above standards, there is a need for Department Attorneys and Child Protection Specialists, owing to their specialized knowledge, to conduct an actual field work and validation during the Palaro to determine prevailing facts and circumstances which would lead to the realization of the full implementation of such, not only during the 2019 Palaro, but also during the next Schools, Divisions, Regional and National Palaros.

In view of the above premises, the Schools Division Superintendents are enjoined to include their Division Attorneys and Child Protection Specialists in their respective Division Office delegation. Activities for participating attorneys and specialists have been mapped out for the duration of the 2019 Palaro.
